In reviewing our scores and comments, the following have been identified as areas for enhancement:

- Supporting children in transitions or changes within the program
- Sharing parenting tips and resources that are helpful to families
- More opportunities for children to explore nature in a variety of ways, both indoors and outdoors

Program learnings and next steps

- In developing our 2023/24 Continuous Quality Improvement Plan we have a focus on well-being through the lens of using the environment as a third teacher to support transitions, as well as providing more parent resources.
- Current playground with climbing structure will be removed and upgraded with a natural playground in the fall of 2023
- Introduction of a new parent app to support ongoing communication to be introduced early in 2024.
